The Public and Taxes

TOPLINE RESULTS

Interviews for this study were conducted on the SSRS Opinion Panel Omnibus, **March 15 – 18 and April 5** – **7, 2024**, among a nationally representative sample of **2,012 adults**. The margin of error for total respondents is +/- 2.44 percentage points at the 95% confidence level. The design effect is 1.25.

The SSRS Opinion Panel Omnibus is a multi-client probability-based survey that fields twice a month. It delivers a nationally representative sample of 1000+ adults age 18 or older in English with a Spanish-language option. Data collection is conducted online and via phone (for non-internet and web-reluctant respondents) using the SSRS Opinion Panel. More information about SSRS is available at <u>www.ssrs.com</u>.
